Chairman

Difficult end to last year's outdoor season with Warton cancelling just about every other session, and a much quieter indoor season.

Christmas, I got an email from Warton CC asking us to vacate the ground due to them running out of evenings, as the club was expending. so, the hunt for a new venue was on.....

Only Morecambe and Lancaster cc offered anything, but Morecambe was going to be way too busy so here we are at Lancaster CC. we moved on 1st February held our first comp a month later.

We were unsure whether this move would be good for the club, with the one-way system being a pain and the distance for some members.

As soon as we moved, we lost 5 members due to distance We came with around 35 members and now we have 56+ members.

We have help 2 open competitions and 1 county open competition.

We have had quite a few archers going to competitions with some good results.

Beginners course numbers have been good since we have moved here approx. 33 people have done beginners courses, 11 have joined so far and We have had 8 members who have joined who have shot previously.

Secretary

Treasurer

Overall financial health of the club remains good with a balance of £16,563.69 an increase of £1,960.48 based on last years balance (14/8/24) annual turnover of approximately £21,107.52

Main ongoing expense is the indoor venue at Dallam (£28/h; £112p/w) and the grounds cost which have increased from £500 per annum at Warton to £1400 per annum at Lancaster CC.

Additional one off costs for the move to Lancaster CC include container purchase (£2,640), Shed maintenance £233, van and skip hire £447, have been offset by increased beginner's courses and visitor's fees.

Additional items of equipment and target faces are the main source of deficit along with miscellaneous fee for equipment maintenance, prizes, web hosting etc. These expenses are offset by the monthly hooting fee, which also covers club AGB affiliation and Cumbria AA affiliation

This year, 23 archers have submitted scores on Golden Records Online (or entered the handicap League and I've done it for them). In target archery, we've had a whopping 35 club records broken. In clout, we've had one record broken (a quiet year for us). And in Flight, we've had 5 records broken. That's a total of 41 successful club record claims this year!
